January 20th—next meeting of HCFEP at Suffield Fire Company #2 (9 Ratley Road) - 7 PM.

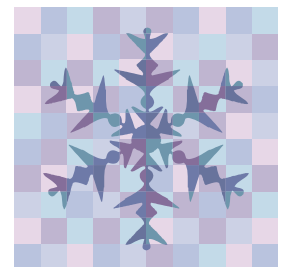
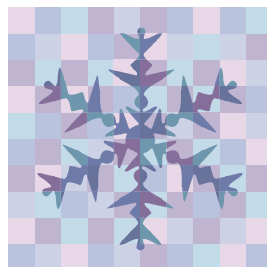
